ABOUT RCCF

Since 2008, Rixon + Cronin has given 5% of every commission to non-profit organizations around the community. In 2018 we joined forces with Spur Community Foundation and created a donor-advised fund, The Rixon + Cronin Charitable Fund, that now operates under Spur's umbrella.

FUNDING RANGE

Grants typically range between \$5,000 - \$10,000. We also generally don't make multi-year grants, although we may fund the same organization on a year-by-year basis over a period of years.

WHAT WE FUND

The Rixon + Cronin Fund is used to make grants to organizations that serve the Wood River Valley and have been designated a 501(c)(3).

We invite grant requests for projects or programs that:

- Will have a broad impact on the quality of life for a significant number of people in our community
- Address community issues and problems
- Are creative in their approach to solving problems
- Program grants support a specific program and are tied to program-based outcomes. Priority consideration is given to applicants who have been assessed and to proposals that address unmet needs.

Successful grant applications typically have the following attributes:

- Address important community needs effectively
- Possess a scope beyond the applicant's current operations and/or funding sources
- Include partnerships and collaboration with other organizations, if applicable
- Have specific goals that are tracked and evaluated

To be eligible for consideration, your organization should meet the following criteria:

- Be a charitable organization determined to be tax exempt status by the IRS
- Actively and broadly serve the Blaine County/Wood River Valley community
- Address an important local community need or opportunity
- Raise a substantial portion of your annual revenue through charitable contributions in the Wood River Valley
